

# Terms of Use of nvpn.work Services

## General Provisions

1. These **Terms of Use** define the conditions under which [Https://nvpn.work/](https://nvpn.work/) **Services** are rendered to YOU (the **User**) to provide unrestricted access to different global Internet Resources.
2. By starting to use the Services, you **must agree** to these Terms of Use in their **entirety**. If you **do not agree** with **any** of the provisions of these Terms of Use, you **should not start or continue using** the Services.

## Personal Data Processing

  - b) any **illegal activities**, such as piracy, fraud, hacking and similar or other punishable by law are made possible, as well as such activities as cyberbullying, harassment and hate speech.
  - c) any **malicious software** like computer viruses, trojans, spyware etc is downloaded, distributed and/or stored,
  - d) the **privacy of other persons** is invaded, including monitoring and/or recording online activities of other persons without their consent.
